IAK Sports Festival Summer 2010

Please keep in mind **two rules** that apply to all tournaments:

1. Participation in these competitions is free for IAK members. Non-members will have to pay **\$5.00 entrance fee** for each event.
2. If enough participants do not sign up for any tournament in any of the leagues, the event will be cancelled and entrance fee returned to those who paid them.

The tentative schedule for this year's summer tournaments is as follows:

June 15-30—Tennis and Badminton (the specific day and time will depend on the availability of the courts and the weather).

July 1-15—Table Tennis and Chess. Participants will be contacted with specific dates and venue.

July 16-30— Bowling. Participants will be contacted with specific dates and venue.

Make sure that you register before the deadline 10th of June. We will make the final decisions on what tournaments to conduct, competition dates and venues on June 10th.
